2. Teaching of Punjabi upto tenth level in your school shall be compulsory and the effort for C.B.S.E. New Delhi to give examination of

Punjabi shall be compulsory and at the same time it is also mentioned that in the event of not doing so, No Objection Certificate shall be taken back.

3. The school management shall make compliance of the notification issued by the Punjab Government under R.T.E. Act 2009 and the rules of the R.T.E./Act-2009 framed for the Punjab State.

4 After getting affiliation of C.B.S.E. New Delhi, the management of the school, shall be bound to pay salary and other allowances to the school teaching staff, and alongwith non teaching staff like the government employees. In the event of not doing so, No Objection Certificate shall be taken back.

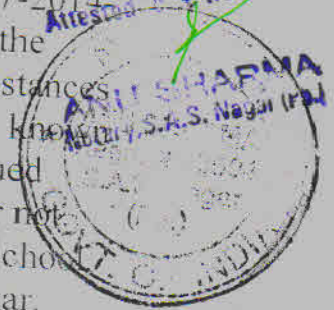
